On 23 September 2020, the Luxembourg Government declared a state of emergency for a period of three months based on article 32(4) of the Luxembourg Constitution. Under the emergency powers granted by the Constitution, the Government has enacted by way of decree a number of temporary measures. These comprise new rules allowing all Luxembourg companies, including investment funds in corporate form, to hold their shareholder meetings (including the annual general meeting) exclusively in digital form.
