Fund Philosophy

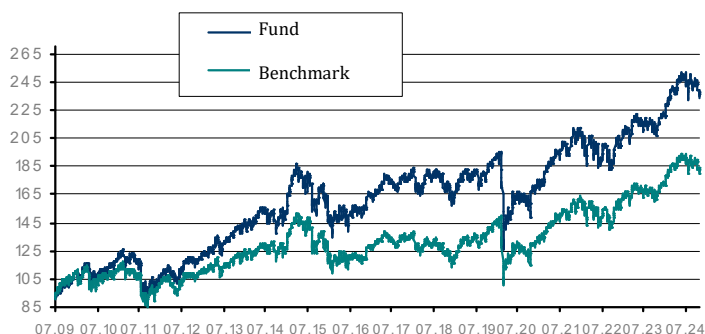
