Fund Philosophy

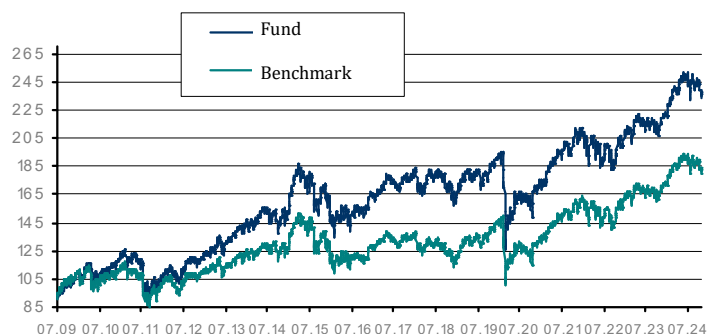
