What is this product?

TYPE

The product is a sub-fund of Planetarium Fund, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However the Board of Directors may decide to close this product under certain circumstances.

OBJECTIVES

The Sub-Fund objective is to obtain a positive performance return on the medium to long term regardless of the market performance pursuing many strategies such as equity long short, equity market neutral, fixed income arbitrage, global macro etc.

The Sub-Fund can invest in funds whose investment selection process involve the use of computers to analyse financial data and identify the investment opportunities.

The Sub-Fund is primarily invested in UCITS and other UCIs, including ETFs that will invest in all asset classes where they identify potential opportunities.

The Sub-Fund is actively managed without any reference to a benchmark. The Investment Manager has discretion over the composition of its portfolio subject to this objective and investment policy.

The Sub-Fund may hold Ancillary Liquid Assets (up to 20% of its net assets) in order to cover current or exceptional payments or for the time necessary to reinvest those Ancillary Liquid Assets in eligible assets. It may invest up to 25% of its net assets in convertible bonds, deposits, money market instruments, equities, government bonds and UCITS and other UCIs, including ETFs, pursuing other strategies than the alternative strategies referred to above.

In order to manage foreign exchange risks, investments in currencies other than the portfolio's reference currency may be hedged.

The Sub-Fund will not use any SFT or TRS.

Sale of shares in the Sub-Fund can be made on any business day.

Any income arising from the Sub-Fund's investments is reinvested and reflected in the value of your shares.

INTENDED RETAIL INVESTOR

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The essential risks of the investment fund lie in the possibility of depreciation of the securities in which the fund is invested.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

What happens if FundSight S.A. is unable to pay out?

The Sub-Fund's assets are held with BNP Paribas, Luxembourg Branch and are segregated from the assets of other sub-funds of the Company. The assets of the Sub-Fund cannot be used to pay the debts of other sub-funds of the Company.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

A performance fee is paid when the sub-fund overperforms its previous HWM over the calculation period, corresponding to the financial year of the sub-fund. The performance fee is calculated and accrued on a daily basis. It is crystallized and paid at the end of the financial year. How long should I hold it and can I take my money out early?

Recommended holding period: 5 years.

The recommended holding period was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible at any time and without limitation. All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 2 p.m (Central European time) on three (3) Business Days (any bank business day in Luxembourg) preceding the relevant calculation day of the NAV. Redemption proceeds shall be paid in the relevant reference currency usually within three (3) Business Days following the relevant calculation day of the NAV.

How can I complain?
