Fund Philosophy

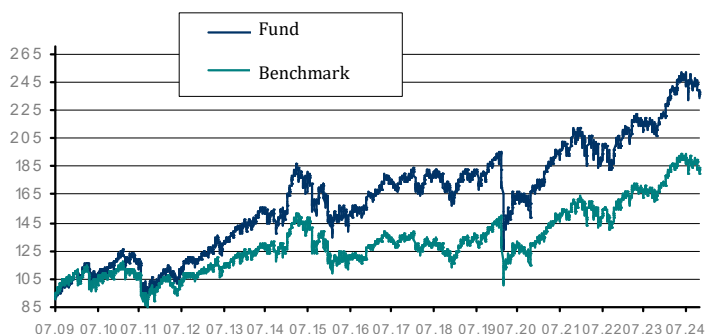
