Fund Philosophy

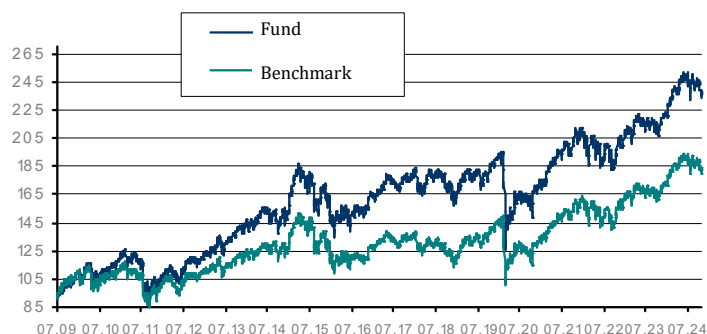

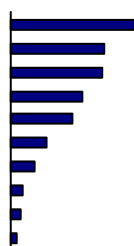
